



## SPECIAL NOTICE TO ALL EMPLOYERS – Effective June 6, 2021

The Agreement between Associated General Contractors of Wisconsin, Inc. and Others and Iron Workers Local 383 is effective June 1, 2020 through May 31, 2023.

The rate for Journeymen Ironworkers from **June 6, 2021 through June 4, 2022** is **\$37.75**. The **Dues Checkoff of \$1.89** per hour is part of the gross hourly rate of **\$37.75**, is taxed and then deducted and submitted at the end of each month along with fringe benefit payments.



One check for the Pension and SMA monies payable to: **Fringe Benefit Fund Account**, P.O. Drawer M, Lansing, IL 60438. One check for the Dues Checkoff, Health Care Plan, Apprentice & Retraining Fund, IMPACT and IAP/Contract Administration monies payable to: **Iron Workers Local 383 Lockbox Account**, P.O. Box 78500, Milwaukee, WI 53278-0500

Fund payments are calculated on HOURS WORKED. The same Dues Checkoff, Pension, SMA, Health Care Plan, Apprentice and Retraining Fund, IMPACT and IAP/Contract Administration contributions paid for Journeymen, also apply to Apprentices. The Working Dues Checkoff is included in the gross wages and deducted after payroll taxes are withheld.
